

TEMPORARY CLOSURE OF 41480 COOMBE ROAD, (WOTTON UNDER EDGE TOWN) STROUD DISTRICT

Gloucestershire County Council have made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of the 41480 Coombe Road, from outside the property known as 1 Uphill for a distance of approximately 50 metres.

The reason for the closure is to install a new water pipe.

GLOUCESTERSHIRE COUNTY COUNCIL TEMPORARY TRAFFIC ORDER 41480 COOMBE ROAD (WOTTON UNDER EDGE TOWN) (STROUD DISTRICT) ORDER 2018

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for 41480 Coombe Road ("the Road") is satisfied that use of part of the Road should be prohibited because works are being or are proposed to be executed on or near it.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

- Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Road from outside the property known as 1 Uphill for a distance of approximately 50 metres;
- 2. Nothing in Article 1 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Road;
- 3. Nothing in Article 1 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Road;
- 4. The Road falls in Wotton Under Edge Town in the Stroud District and in the County of Gloucestershire;
- 5. This Order shall come into operation on the 10th day of July Two Thousand and Eighteen and shall continue in force for a period not exceeding eighteen months;
- This Order may be cited as "Gloucestershire County Council Temporary Traffic Order 41480 Coombe Road (Wotton Under Edge Town) (Stroud District) Order 2018".
