P.5827 Minutes of Planning Meeting To approve Minutes of July 2018. It was proposed by Cllr N Pinnegar and seconded by Cllr P Smith to approve these Minutes, agreed 6 in favour 2 abstentions.

P.5828 Correspondence

- a) To update WTC regarding SDC's felling of trees in Bearlands to make way for structures for new rubbish bins & WTC enquiry if they needed planning permission. SDC responded that extensive consultation had been carried out with Bearlands occupants with residents in favour of new bins, that the tree was diseased necessitating felling, and that planning permission was not necessary. Town Council disagrees with this response and District Cllr Tucker is making further enquiries. Those new bins are still not yet in use and rubbish is overflowing. This town council is not sure if the mismanagement of this project by SDC is deliberate or undeliberate incompetence and awaits an explanation.
- b) Glos CC Highways Development Mgmt; Site Of Former The Full Moon; Discharge of conditions 3 (Materials), 5 (Landscaping), 7 (CMS), 8 (Management and Maintenance) and 9 (Trees) from application S.14/2430/FUL. The revised Construction Environmental Management Plan received on 8th August 2018 and associated Site Traffic Management Plan 1818-WD-052 are acceptable. Noted.

A different developer to the planning applicant is now developing the site and work has started, with issues such as broken sewer piper for a neighbouring property and cutting through BT cables. Also it appears that more land has been fenced off than appropriate towards The Green and this will be investigated by Councillors. Clerk to forward exact plans for reference.
