

## TEMPORARY CLOSURE AND RESTRICTION OF VARIOUS ROADS, STROUD DISTRICT

Gloucestershire County Council has made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close and restrict part of the roads as detailed in the Schedule below.

The reason for the closure is for carriageway resurfacing.

The roads are expected to be closed and restricted during various times on a rolling programme commencing 1<sup>st</sup> October 2018 where the presence of approved signage will indicate whether the closures and restrictions are in force. Further advance warnings of dates/times will be displayed on site prior to the closure taking effect. This order can permit the closure and restriction of the roads in any order, or simultaneously as required and it is anticipated all works will be completed by 31<sup>st</sup> December 2018. There will be no parking or waiting permitted throughout the duration of the works.

## GLOUCESTERSHIRE COUNTY COUNCIL TEMPORARY TRAFFIC ORDER VARIOUS ROADS IN STROUD DISTRICT ORDER 2018

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for various roads in the Stroud District as defined in the schedule below ("the Roads") is satisfied that use of the Roads should be prohibited and restricted because works are being or are proposed to be executed on or near them.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

- 1. No person shall park nor wait or cause anyone to park nor wait along the Roads throughout the duration of the works;
- 2. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Roads;
- 3. Nothing in Article 2 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Roads;
- 4. Nothing in Article 2 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Roads;
- 5. The Roads fall in various Parishes within the boundary of the Stroud District in the County of Gloucestershire;
- 6. This Order shall come into operation on the 1<sup>st</sup> day of October Two Thousand and Eighteen and shall continue in force for a period not exceeding eighteen months;
- 7. This Order may be cited as "Gloucestershire County Council Temporary Traffic Order Various Roads in Stroud District Order 2018".
- 8. The prohibitions shall only operate when indicated by the traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016.
