TEMPORARY TRAFFIC ORDER
C375 Church Street (Wotton Under Edge Town)
(STROUD DISTRICT) ORDER 2018

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for C375 Church Street from its junction with B4058 Culverhay to the one-way section of Church Street for approximately 9 metres ("the Road") is satisfied that use the Road should be prohibited because works are being or are proposed to be executed on or near it.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Road
2. Nothing in Article 1 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Road;
3. Nothing in Article 1 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Road;
4. The Road falls in Wotton under Edge Town in the Stroud District and in the County of Gloucestershire;
5. This Order shall come into operation on the 15th day of October Two Thousand and Eighteen and shall continue in force for a period not exceeding eighteen months;
6. This Order may be cited as "Gloucestershire County Council Temporary Traffic Order C375 Church Street (Wotton Under Edge Town) (Stroud District) Order 2018".

**TEMPORARY CLOSURE OF C375 CHURCH STREET
(WOTTON UNDER EDGE TOWN) STROUD DISTRICT**

Gloucestershire County Council has made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of the C375 Church Street from its junction with B4058 Culverhay to the one-way section of Church Street for approximately 9 metres.

The road is expected to be closed from 15th October 2018 until 16th October 2018 between the hours of 08:00 hours and 16:00 hours only or until the works have been completed.
