

GLOUCESTERSHIRE COUNTY COUNCIL
TEMPORARY TRAFFIC ORDER
3/284 WORTLEY ROAD (WOTTON UNDER EDGE TOWN)
STROUD DISTRICT ORDER 2019

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for the 3/284 Wortley Road from its junction with Bearlands to its junction with Nind Lane for a distance of approximately 300 metres ("the Road") is satisfied that use of the Road should be prohibited because works are being or are proposed to be executed on or near it.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Road;
2. Nothing in Article 1 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Road;
3. Nothing in Article 1 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Road;
4. The Road falls in Wotton Under Edge Town in the Stroud District and in the County of Gloucestershire;
5. This Order shall come into operation on the 18th day of February Two Thousand and Nineteen and shall continue in force for a period not exceeding eighteen months;
6. This Order may be cited as "Gloucestershire County Council Temporary Traffic Order 3/284 Wortley Road (Wotton Under Edge Town) Stroud District Order 2019".

**TEMPORARY CLOSURE 3/284 WORTLEY ROAD (WOTTON UNDER
EDGE TOWN) STROUD DISTRICT**

Gloucestershire County Council has made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of road number 3/284 Wortley Road from its junction with Bearlands to its junction with Nind Lane for a distance of approximately 300 metres.

The reason for the closure is to renew a water meter within the carriageway.
